

Rules for golfers at Golf Valley golf course during COVID-19 to protect our members and employees

Basic rule: "Please keep your distance"

- We ask all golfers in their own interest and in the interest of everyone to show solidarity and to follow all necessary rules
- If the regulations are not complied with, a long ban can be issued. Those measures are necessary in order to prevent this Club from closing down again!
- Please note that changes and/or additions can occur at any time!
- Strictly follow the applicable distance and hygiene rules (RKI)



Detailed (provisional) regulations:

Version 3 / November 30, 2020



- Check symptoms of illness and your health risk **BEFORE** entering the golf course!
- Only enter the facility if you are completely healthy!
- Always carry a (hand-)disinfection bottle during your stay at Golf Valley!



Teetime booking

- Playing is only possible with prior reservation!
- Teetime reservations are only bookable via PC Caddie!



Arrival and departure

- Please do not arrive earlier than 30 minutes before your booked teetime!
- Please keep sufficient distance between the vehicles!
- Please avoid group formation at the parking lot on arrival and departure!



Reception

- A maximum of 2 players may enter the reception at the same time!
- Reception can only be entered with mouth-nose-protection!
- Adhere to the distance rules and hygiene regulations!
- Locker rooms in the clubhouse are closed!

• We kindly ask you to avoid paying in cash

• Guests pay post-season prices













Caddy hall

Payment

• The caddy hall can only be entered with mouth-nose-protection in compliance with the clearance rules and hygiene regulations!



• The instructions of the employees must be followed!



- Register at the Clubhouse at least 10 minutes before you tee-off
- Do not tee-off without a prior booked teetime!



Distancing

• Keep the necessary distance from other players and employees especially inside the clubhouse, the golfshop, at the exercise area and at the golfcourse

• Only use your own equipment!



No shaking hands or touching!



• Wash your hands whenever you can!



Do not pass on any contaminated food, balls, teas, clubs or tolls



On the course

- Only touch your own ball!
- Do **NOT** operate, pull or touch the flags!
- Please remove pitch marks!
- Bunker rakes are removed clean the bunkers with your feet or club!
- Ball washer and club washer have been removed!
- Avoid "playing through" play quickly!
- Note extraordinary COVID-19 rules!
- Restrooms (next to kiosk) are open note special instructions!
- Shelters are closed in case of thunderstorm leave the course immediately!

Practice areas (chipping, pitching, putting)

- Keep your distance and only use your own balls.
- Pay attention to contact hygiene.

Driving Range

- Use your hand disinfection bottle before you touch ball machine and baskets
- Only play within the marked areas



Golf-Carts

- The use of carts is due to post-season not permitted any more
- After November 2nd, only carry bags can be used



OTHER IMPORTANT NOTES

By booking your teetime you agree to all rules and regulations above.

If individual provisions are not complied with, this will lead to an immediate eviction, combined with a subsequent course ban!

Golf Valley GmbH employees will check compliance with the rules!

The instructions of the employees must be followed!

It is not allowed to start without pre booked teetime – teetimes can be booked between 9am and 5pm or online.
